**AGREED TEMPORARY RESTRAINING ORDER**

On November 30, 2021, Plaintiff's Motion for Temporary Restraining Order came before the Court for hearing. Having considered the Motion, including the attached Declaration of Christine Wellborn, other attachments, argument of counsel for Plaintiff and all Defendants, and in light of the Parties' agreement, the Court GRANTS the Motion in part and DENIES the Motion in part. It is therefore,

ORDERED, ADJUDGED, and DECREED that MATT LANGSTON, JACKIE SCHLEGEL, ENGAGERIGHT, LLC and TEXANS FOR VACCINE FREEDOM be enjoined as follows:

- a. Defendants, MATT LANGSTON, JACKIE SCHLEGEL, ENGAGERIGHT, LLC and TEXANS FOR VACCINE FREEDOM, individually and in any combination, shall cease all communications in the name of Texans for Vaccine Choice and reference to Jackie Schlegel as Executive Director of Texans for Vaccine Choice;

b. Defendants, MATT LANGSTON, JACKIE SCHLEGEL, ENGAGERIGHT, LLC and TEXANS FOR VACCINE FREEDOM, individually and in any combination, are ordered to not communicate with current or prospective members, donors, and volunteers in an attempt to rebrand, rename, or otherwise cause confusion in reference to the identity, leadership, and mission as for and between Texans for Vaccine Choice and Texans for Vaccine Freedom;

This matter is set for a hearing on Plaintiff's application for a temporary injunction hearing on December 7, 2021 at 3:30 p.m. before the Honorable Melody Wilkinson. This Order shall expire at that same date and time.

It is further ORDERED, ADJUDGED, and DECREED that this Order shall not be effective unless and until Texans for Vaccine Choice executes and files a bond or a cash bond with the Clerk, in conformity with the law in the amount of \$100.00.

All other relief not expressly provided for herein is DENIED.
