FULL SCHEDULE NEVER TESTED

MORE ABOUT THE NATIONAL CHILDHOOD VACCINE INJURY ACT OF 1986

This law freed vaccine manufacturers from liability when injury or death following vaccination occurs. Without the risk of liability, vaccine makers have zero incentive to make their products safe or effective

"No vaccine manufacturer shall be liable in a civil action for damages arising from a vaccine-related injury or death." 42 U.S. Code§ 300aa-22, Standards of Responsibility

This act set up the **Vaccine Injury Compensation Program** to offer recourse to victims of vaccine injury and death. This program established a no-fault "vaccine court" that was intended to be a quick and easy way for victims to receive compensation funded by an excise tax collected on every vaccine dose administered. Unfortunately, this court has resulted in a lengthy and contentious process in which victims of vaccine injury rarely receive just treatment. The majority of cases are dismissed. The ones that are accepted receive nominal compensation that does little to cover the associated costs.

Even so, since its inception, the VICP has awarded over \$5,000,000,000 in injury and death payouts. No other product in this country is essentially mandated without consumer protections.
